- If participating in a "RIDE/Walk Anywhere" location option, I acknowledge that I have chosen to participate without direct staff or volunteer oversight or support; and I acknowledge that I am responsible for selecting the route with my team; and I agree to participate with at least three (3) other participants, where at least one of the participants has a working cell phone to use for emergency purposes;
- In consideration of the acceptance my participation in the Event, I, for myself, my heirs, executors, administrators, successors and assigns waive any claims to which I may become entitled for injury or damage or other liability regardless of cause and release Blue Sea Philanthropy Inc., the local host charity, or organizing committee members (referred to collectively hereinafter as the "Organizers") and all other organizers, sponsors, representatives, their agents and employees and any other person or organization assisting in this Event from any claims for damages or injury suffered by me as a result of my participation in or travelling to or from this Event.
