- I (referred to hereinafter as the "Participant") understand the inherent risks in participating in the Ride for Refuge whether cycling, walking, or any of the RIDE Freestyle activities, and assume all risks for personal safety. I acknowledge that I have chosen to participate without direct staff or volunteer oversight;
- I agree to obey all laws and recommended community guidelines regarding gatherings, and if applicable, laws regarding food safety, traffic signs, and lights, that, if riding a bicycle, I will wear my regulation bicycle helmet (regardless of whether provincial or state laws permit otherwise), and that I will ride in single file;
- I will cooperate fully with the Organizers, as defined in Paragraph 6 below, including modifying, changing, or stopping my participation if requested to do so;
- I confirm that I am in proper physical and emotional condition to participate in this Event;
- If my selected RIDE activity is a physical and/or outdoor activity, I agree to participate with at least three (3) other participants, where at least one of the participants has a working cell phone to use for emergency purposes;
- In consideration of the acceptance my participation in the Event, I, for myself, my heirs, executors, administrators, successors, and assigns, waive any claims to which I may become entitled for injury or damage or other liability regardless of cause and release Blue Sea Foundation, the local host charity, or organizing committee members (referred to collectively hereinafter as the "Organizers") and all other organizers, sponsors, representatives, their agents and employees, and any other person or organization assisting in this Event from any claims for damages or injury suffered by me as a result of my participation in or travelling to or from this Event.
- I give my permission to the Organizers to use of my name and picture in broadcast, telecast, internet, mediated, or written account of this Event.
